Spotlight on The Community Guide: A Vital Resource for Public Health

The Community Preventive Services Task Force (CPSTF), established by the U.S. Department of Health and Human Services (DHHS) in 1996, plays a crucial role in identifying effective community-based health interventions. The CPSTF's recommendations, compiled in The Community Guide, serve as the "Gold Standard" for promoting and improving public health. Updated every five years, these guidelines focus on key priority areas using rigorous, data-driven processes.

Why is this guidance so important? In 2023, the CPSTF highlighted patient navigation as an effective intervention to increase cancer screenings—specifically for breast, cervical, and colorectal cancers—among historically underserved racial and ethnic groups and individuals with lower incomes. This recommendation was supported by a systematic review of 34 studies, underscoring the critical impact of patient navigation services on reducing health disparities. The guide states that patient navigation services increase breast, cervical, and colorectal cancer screenings among historically disadvantaged racial and ethnic populations and people with lower incomes.



What is VOICES of Black Women?

VOICES of Black Women is a long-term study run by the American Cancer Society that aims to enroll at least 100,000 Black women in the US during the next few years. The goal of this study is to better understand health conditions like cancer and how to improve overall health among Black women.

At the American Cancer Society, equity in cancer care for all is at the heart of our mission. We prioritize work that helps ensure everyone has an opportunity to prevent, detect, treat, and survive cancer. It's with this vision in mind we're excited to launch a new groundbreaking population cohort study – VOICES of Black Women – underscoring our commitment to better understand how this demographic is impacted by cancer disparities.
