Karen Costello, MSS, LSW, OSW-C, Joins ACS as Strategic Director of ACS NNRT



Karen Costello, MSS, LSW, OSW-C, a seasoned oncology social worker and administrator, has joined the American Cancer Society as the Strategic Director of the National Navigation Roundtable (ACS NNRT). With 30 years of experience spanning clinical coordination, patient navigation, and leadership in academic cancer centers, hospitals, and advocacy organizations, Karen brings deep expertise in oncology support services.

Her career began at the Abramson Cancer Center at the University of Pennsylvania, followed by leadership roles at The Leukemia & Lymphoma Society and Cancer Support Community, where she built a nationally recognized navigation program. Karen holds multiple professional credentials, including ACS Leadership in Oncology Navigation (LION) and Board of Oncology Social Work (BOSW) certification.

As of January 2025, Karen serves on the board of the Association of Oncology Social Work (AOSW) and leads its Advocacy Committee. Her personal experience as a caregiver has shaped her commitment to improving patient access to care and advancing the role of oncology navigation.



Patient Navigation Roles by Level: Entry, Intermediate, and Advanced

Did you know there are 3 levels of patient navigation (entry, intermediate, and advanced) ENTRY

[knowledge & comprehension] is an individual with one to two years or equivalent experience. Starting a new position without experience in navigation and builds on resources for addressing barriers (logistical, economic, cultural & linguistic, communication, and provider centered) and basic Oncology Patient Navigator-Certified Generalist (OPNCG) principles to guide practice.

VOICES of Black Women



In May 2024, the American Cancer Society launched the VOICES of Black Women study—a long-term health study, which will be powered by the perspectives of 100,000 Black women in all 50 states and Washington, D.C. The goal of this study is to better understand how and why health conditions like cancer disproportionately affect Black women so that we can strive for enhanced health outcomes for current and future generations. This study adds to ACS's long history of conducting large-scale population studies (known as the Cancer Prevention Studies), where more than 2.5 million participants have helped us improve our understanding of cancer to inform guidelines for cancer screening and prevention, advocacy, and patient support programming. As such, VOICES is a continuation of this legacy and a manifestation of our vision of ending cancer as we know it, for everyone.

As our trusted partner, we know that VOICES of Black Women is in direct alignment with our shared goals to promote equitable health outcomes across populations. By collaborating with the American Cancer Society, you will join over 300 partnering organizations who have committed to make a lasting impact on community health, together.
