2025**

ACS NNRT Policy Task Group is preparing to launch its second Pulse Survey, focused on how the new Patient Navigation billing codes (CMS PIN Codes and AMA CPT Codes) are being used in practice. We want to hear directly from you—what's working, what's not, and what still

needs clarification.

Why now? The 2025 Medicare Physician Fee Schedule is expected to be released soon. Once it drops, ACS NNRT will send out the survey to gather real-time feedback that can inform policy and implementation moving forward.

Thank you for your continued commitment to strengthening patient navigation nationwide. Your voice is essential to ensure that reimbursement policy reflects the real needs of programs and patients.

Fast Facts: Cancer Treatment and Survivorship

ACS releases new Cancer Treatment and Survivorship Statistics

According to a [new ACS report](#), Cancer Treatment and Survivorship Statistics, 2025, the number of people living with a history of cancer in the United States is estimated at 18.6 million as of January 1, 2025, and projected to exceed 22 million by 2035. The study also found notable disparities in treatment for many common cancers, including lung and colorectal.
