We're excited to share the American Cancer Society National Roundtables 2024 Impact Report with you! Thanks to your dedication and partnership, we made exciting progress tackling cancer's most complex challenges.

Here are just a few of the milestones the ACS National Roundtables achieved last year:

- We expanded our platform for convening, launching the **ACS National Prostate Cancer Roundtable** and the **ACS Hematologic Cancer Collaborative**.
- In 2024 and 2025, two long-time ACS National Roundtables volunteers were honored with the prestigious **ACS Volunteer Leadership Award**.

- We hosted **16 in-person events** and **35 webinars** to strengthen collaboration and inform on best practices, drawing **4,328 attendees**.
- We produced **32 resources** that translate evidence into practice.

Notice for the ACS Roundtable Rules For Engagement will be shared annually or at any time the document is amended throughout the year.

The Rules for Engagement of the American Cancer Society Roundtables clarify the expectations for participation by members of the National Navigation Roundtable, including organizational, corporate, affiliate, and invited individual members, and all individuals acting as representatives of an organizational, affiliate, or corporate member. Members are expected to respect and comply with these Rules and all other applicable ACS policies, observe high standards of conduct, and participate in establishing and maintaining such high standards.
